



Home Boarding / Day-care Request Form

Welcome to Borders Boarding!

We're delighted you're considering us for your dog's home boarding. To ensure a perfect stay, we require some pre-stay information and to arrange a Pet Experience / Trial Day to see how your dog settles in.

Next Steps:

1. **Pre-Stay Info** – Complete and return our form with your dog's vaccination records.
2. **Pet Experience / Trial Day** – We assess how your dog gets on with us and our dogs.
3. **Booking** – If all goes well, future stays simply require date requests.

Boarding Package:

- **Standard Boarding:** £38 per night (12 midday arrival to 11 am departure).
- **Early Drop-off / Late Collection:** £30 per day
- Dogs stay with our two dogs and possibly others, with group walks (min. 20 mins daily).
- Provide your dog's food, treats, bedding, and feeding routine.

Your Dog's Health.

In Order to board dogs in the UK, it is a legal requirement that your dog be vaccinated for:

1. Canine Distemper
2. Infectious Canine Hepatitis (Canine adenovirus)
3. Leptospirosis (L. canicola and L. icterohaemorrhagiae)
4. Canine Parvovirus and other relevant diseases.

We will need to see your UpToDate Vaccination Certificate prior to our first meeting and to receive an updated copy (paper or electronic) each year. A Titre certificate from a vet is an acceptable alternative to a booster vaccination. Primary vaccinations must be completed at least 2 weeks before the boarding dates and Homoeopathic vaccinations and treatments are **not** allowed under UK law as alternatives.

In the event of an emergency, I authorise you (the Veterinarian) to administer medical treatment you deem necessary and in the best interest of my pet and consent for surgery to be performed if necessary. I understand that the vet (s) will take whatever steps that are necessary for the welfare of my pet in an emergency and that every attempt will be made to contact myself, the owner and / or my emergency contact if such a situation occurs.

Furthermore, I give Borders Boarding permission to transport my dog (s) to a veterinarian and authorise treatment in the event of an emergency or sickness. I understand that a charge will be made for the treatments and that a fee may be made for a pet taxi cost. Should emergency care be required outside of normal vet opening hours, I authorise that my dog may be taken to the nearest Veterinarian Emergency Clinic / Hospital
I give permission to Borders Boarding to approve treatment up to £ (indicate maximum £ amount or "no limit"). I agree to be responsible for all charges upon my return including, but not limited to, vet fees, medication fees, extra visit fees and transportation fees.
In the unfortunate event of death of my pet, I also request that my dog (s) to be kept at the vet practice until my return.

Agreement, Payment, and Cancellation

We will send you an Invoice in advance of the stay. Your payment is then held as per the cancellation conditions below. Your place is guaranteed for 48 hours following the issuing of the invoice and may then be released if the payment or deposit hasn't been received within that timeline.

Should you need to cancel your booking, we will need to charge you a portion of the total fee depending on the timescale. The closer to the actual date, the higher the portion, because it gives us no time to re-fill your slot with another dog. Here's how it works:

- Cancellation within 30 or fewer days, of the arrival date is charged at 100%.
- Cancellation between 31 and 60 days, charged at 50%.
- Cancellation over 61 days, No charge

Should you not be able to collect your dog on the agreed date and time, (please, please give us plenty of notice and we will charge a pro rata fee and add the additional costs to a final bill. If you collect your dog before the end of your booking, no refund will be given, as there is no chance for us to fill the empty days with another dog.

****** We are not able to board intact males, or non-spayed females who may come into season during your holiday or are in season at the start of the board, should they come into season prior to boarding or during boarding, we reserve the right to cancel the booking******
